Brokerage commission schedules are established by Lincoln. Pershing charges trading and account service fees. Lincoln Investment, as introducing broker-dealer, has added a mark-up on commissions-based accounts that ranges from 0% to 375% on Pershing's trading and account service fees and a mark-up on fee-based accounts that ranges from 0% to 100% on Pershing's account service fees. The receipt of these fees creates a conflict of interest for Lincoln Investment and its affiliate, Capital Analysts, since it creates an incentive for Lincoln Investment and Capital Analysts to continue to use Pershing in order for Lincoln Investment to receive these fees.
